

# Contest : Dream Garage

## CONTEST RULES

### 1. ORGANIZER

The contest is conducted by Gestion Km/h Inc. for the Montreal Auto Show and the Quebec City Auto Sport Show.

### 2. ELIGIBILITY

To participate and win, the participant must be a resident of the province of Quebec who has reached the age of majority at the time of registration.

Excluded are: administrators, officers, executives, employees, agents, and representatives of the Contest Organizer, its parent company, any company, trust, or other legal entity controlled by or affiliated with them, advertising and promotion agencies, prize suppliers, and service providers in the context of the Contest, as well as the immediate family members (brothers, sisters, children, father, mother, legal or common-law spouse, regardless of their place of residence) of the aforementioned persons or persons with whom they are domiciled (whether or not related).

### 3. DURATION

Registrations begin on January 18, 2024, and end on May 5, 2024, at 2:59 PM Eastern Time.

### 4. PARTICIPATION

The draw will take place at the Quebec City Auto Sport Show, centre de foires d'ExpoCité Building A, 250 Wilfrid-Hamel Boulevard, Quebec City (QC) G1L 5A7

The winner will be randomly selected from all eligible entries received during the Contest Period.

## 7. PRIZE CLAIMING

In order to be declared a winner, any selected participant must:

- a) Be reached by phone or email, at the sole discretion of the Contest Organizer, within two (2) days following the draw. Any selected participant who cannot be reached after appropriate and reasonable efforts by the Organizer during this period will be disqualified, and a new draw will be conducted to award the prize. In the event that a selected participant was contacted by email, they must respond in accordance with the provided instructions, if any. Any prize notification email followed by a message stating that the message could not be delivered will result in the disqualification of the participant and the selection of a new participant;
- b) Sign the Declaration and Release Form, which will be sent to them by the Organizer, and return it to the Organizer within two (2) days of receiving it;
- c) Have correctly and unassisted, including mechanically, answered the mathematical skill-testing question;
- d) Provide, upon request and in a timely manner, valid photographic proof of identity.
